The Colorado Planned Giving Roundtable (CPGR) Fellowship Program Program Overview

As the Baby Boomers begin to retire from management positions with charities both nationally and locally, it can be more difficult for non-profit organizations to find enthusiastic staff members who are ready, willing and able to move into the challenging leadership positions being vacated. CPGR hopes to encourage talented new professionals to remain in the nonprofit sector, particularly those who are interested in careers in fundraising and planned giving.

The goal of the new CPGR Fellowship Program is to introduce the Roundtable and its various programs and opportunities to fundraising professionals across the state who:

- are experienced fundraising professionals, but new to planned giving
- have little fundraising experience, but are now responsible for all or part of a nonprofit's fundraising, including planned giving

Candidates from diverse backgrounds, those who work for smaller organizations, as well as those serving underserved communities are particularly encouraged to apply for the Fellowship Program.

The Fellowship program is an effort to reach out to new fundraising professionals or nonprofit professionals by offering an opportunity to participate in a two-year program that will:

- enhance their professional development and fundraising training, particularly in the area of planned giving
- offer access to networking opportunities, as well as fundraising and planned giving resources
- assist them in developing their organization's own planned giving program

This program will help fulfill CPGR's mission to increase the quantity and quality of charitable planned gifts in our community by expanding our efforts to offer quality planned giving education, increased awareness and networking opportunities.

CPGR's Fellowship Program will be conducted on an annual basis beginning January 2009. Applications to the program will be accepted beginning in the fall with a deadline of **December 1, 2008**. Applications will be reviewed and Fellowship 2009 recipients will be notified by **December 20, 2008**. The application will include permission from the candidates' supervisor and/or the Chair of the Board/CEO/Executive Director of the hiring organization.

Candidates may come from Colorado or the surrounding states, but since attendance at a number of programs throughout the year is required, it is expected that candidates will most often be drawn from the metro-Denver area. Candidates who are able to travel to meet this commitment will be considered. The goal for the first year is 2-4 Fellows.

Fellows will receive:

- A complimentary membership to CPGR for two years
- Preference for a Summer Symposium scholarship
- An assigned member partner to serve as an advisor
- The fee waived for three of the five luncheon programs

Fellows will be required to:

- Attend four CPGR programs in the first year (to include Luncheon Programs, Brown Bag Series and Technical Series programs). *Note: There is no charge for CPGR members for the Brown Bag & Technical Series*
- Work with a CPGR committee to complete a project related to that committee's charge
- Meet quarterly with their Member Partner (two meetings face-to-face, two may be by telephone)

In the second year, each fellow will meet with the Fellowship committee to advise them on program evaluation and enhancements and is expected to attend at least three programs. The Fellow will complete a written evaluation of the program annually as well as participate in the Fellowship planning process for the second year of the program.

The Board President will appoint an ad hoc committee of three to four persons to oversee the program with the assistance of the Executive Director. Candidates for the Ad Hoc committee include but are not limited to the Board president, a member of the CPGR board, a member of the original fellowship planning committee, and a member of the sponsor organization.

The Ad Hoc committee will:

- Review the fellowship applications using the same scoring guidelines used by the Summer Symposium Scholarship Program
- Select the Member Partners to be matched with each Fellow
- Plan and hold the Fellow orientation in January
- Monitor the program on a quarterly basis and file a report with the Board
- Provide guidance for the program
